

TO BE SIGNED ONLY BY REGISTERED VOTERS

PETITION FOR PROPOSED ORDINANCE BY INITIATIVE

The following question shall be submitted to the People of the City and County of Honolulu to be voted upon at either a general or special election:

SHALL AN ORDINANCE BE ADOPTED WHICH LIMITS THE LENGTH OF THE CITY'S OFFICIAL RAIL ROUTE AND THE NUMBER OF RAIL STATIONS IN ORDER TO MAKE THE CITY'S CONSTRUCTION, OPERATION AND MAINTENANCE OF HONOLULU'S RAIL TRANSIT PROJECT AFFORDABLE?

WE, THE UNDERSIGNED, AS DULY REGISTERED VOTERS IN THE CITY & COUNTY OF HONOLULU PROPOSE AN ORDINANCE THAT SHALL:

1. AMEND THE CITY'S LOCALLY PREFERRED ALTERNATIVE OR "LPA" FOR THE HONOLULU HIGH-CAPACITY TRANSIT CORRIDOR PROJECT TO A SHORTER ROUTE CONNECTING EAST KAPOLEI WITH MIDDLE STREET ONLY;
2. AMEND THE CITY'S MINIMUM OPERABLE SEGMENT OR "MOS" FOR THE HONOLULU HIGH-CAPACITY TRANSIT CORRIDOR PROJECT TO A SHORTER ROUTE CONNECTING EAST KAPOLEI WITH MIDDLE STREET ONLY;
3. REQUIRE THE CITY ADMINISTRATION AND/OR THE HONOLULU AUTHORITY FOR RAPID TRANSPORTATION (HART) AS WELL AS THE FEDERAL TRANSIT ADMINISTRATION (FTA) TO RECOGNIZE THE CITY'S NEW, TRUNCATED LPA AND MOS FOR THE CITY'S FIXED GUIDEWAY SYSTEM.

Pursuant to Chapter 4, Section 3-402(4) of the Revised Charter of the City and County of Honolulu, a full draft of the proposed ordinance may be attached and will be made a part of such petition. Pursuant to Section 3-406 of the Revised Charter of the City and County of Honolulu, we designate and authorize the following committee to approve any alterations in form or language, or any restatement of the text of the proposed ordinance which may be made by the corporation counsel of the City & County of Honolulu: Emil Svrčina, Marissa Kerns and Eric Ryan.
